ORDER AUTHORIZING JUDICIAL MEDIATION

To further implement section 652(a) of the Alternative Dispute Resolution Act of 1998, 28 U.S.C. § 651 et. seq., in addition to the procedures set forth in E.D. Mich. L.B.R. 7016-2, the Court authorizes the judicial officers of the district with their consent to act as judicial mediators for matters in cases over which they are not presiding.
