## POST-CONFIRMATION ORDER

The Court entered an order confirming a plan in this case. Pursuant to 11 U.S.C. § 1106(a)(7) and Bankruptcy Rule 3022, to provide a schedule for final action in this case, it is therefore

**ORDERED** that the Debtor shall obtain settings for hearings on all applications for the award of compensation or expenses and motions for administrative expenses, and, consistent with the notice requirements of Bankruptcy Rule 3007, to determine objections to claims, and it is further

**ORDERED** that the Debtor, after substantial consummation as defined under 11 U.S.C. § 1101(2), shall file an application for final decree, and it is further

ORDERED that if the application for final decree is not filed within 180 days of the entry of this Order, a status conference will be held on MAY 18, 2016 AT 9:00 AM, at US FEDERAL COURTHOUSE, 1000 LAMAR STREET, ROOM 222, WICHITA FALLS, TEXAS, 76301, and it is further

**ORDERED** that if the Debtor does not appear at the status conference, the Court, on its own motion, may enter a final decree closing the case pursuant to Bankruptcy Rule 3022 or dismiss the case, and it is further

**ORDERED** that the Debtor shall certify that copies of this order were mailed to all creditors and other parties in interest within 14 days of entry of this order.
