Court Web: Judges as Authors: What Do Readers Want?

The Federal Judicial Center has provided the attached materials to assist courts in program planning and in applying for continuing legal education (CLE) credit for the webcast *Court Web*: *Judges as Authors: What Do Readers Want?*.
