FEES FOR ADMISSION TO FEDERAL COURT BARS

Tim Reagan Federal Judicial Center 2024

This is a report on fees charged for admission to the attorney bars of federal courts of appeals and federal district courts. It was prepared for a subcommittee on attorney admissions created by the Judicial Conference's standing Committee on Rules of Practice and Procedure.¹

Fees for admission to the bars of the courts of appeals range from \$214 to \$300. For the district courts, fees range from \$199 to \$350. State and territory bars charge from no fee to \$50 for certificates of good standing.

The fee for original admission to a federal bar is \$199 plus any additional fee that the local court charges.² The national fee was increased from \$188 to \$199, and the fee for a certificate of good standing from a federal bar was increased from \$20 to \$21, on December 1, 2023.³

The federal government and federal agencies or programs that are funded from judiciary appropriations are exempt from the national fee.⁴ Requirements for practice by federal government attorneys are also constrained by statute:

The Solicitor General, or any officer of the Department of Justice, may be sent by the Attorney General to any State or district in the United States to attend to the interests of the United States in a suit pending in a court of the United States, or in a court of a State, or to attend to any other interest of the United States.

28 U.S.C. § 517.

Some federal-court bars charge periodic renewal fees.

Certificates of Good Standing from State and Territory Bars

Membership in a district court's bar requires proof of membership in another bar, as specified by the court's local rules. Certificates of good standing are proof of bar membership, and the fees charged for them in the states and territories range from no fee to \$50.

Ten jurisdictions (including American Samoa) charge no fee (18%). Another ten jurisdictions (including Puerto Rico) charge a fee that is less than \$10 (18%). Nineteen jurisdictions charge from \$10 to \$20 (34%), and thirteen jurisdictions (including the District of Columbia, Guam, and the Virgin Islands) charge the most common fee of \$25 (23%). The remaining four jurisdictions (including the Northern Mariana Islands) charge \$40 or \$50 (7%).





The Federal Courts of Appeals

According to Federal Rule of Appellate Procedure 46(a)(1), attorneys licensed to practice law in the United States are generally eligible for admission to each circuit's appellate bar:

An attorney is eligible for admission to the bar of a court of appeals if that attorney is of good moral and professional character and is admitted to practice before the Supreme Court of the United States, the highest court of a state, another United States court of appeals, or a United States district court (including the district courts for Guam, the Northern Mariana Islands, and the Virgin Islands).

Admission requires (1) submission of an application, (2) motion by a current bar member, and (3) payment of a fee.⁵

The median bar admission fee is \$239, and the range is from \$214 to \$300. Bar admission in the Second, Fifth, and Eleventh Circuits is for a term of five years. Renewal fees are \$25, \$50, and \$20, respectively.

Only the Eleventh Circuit's court of appeals posts a pro hac vice fee (\$50). Only the rules for the District of Columbia, Second, and Fourth Circuits appear to mention pro hac vice appearance.

Federal Appellate Bar Fees



The Federal District Courts

In the district courts, admission fees range from the national minimum of \$199 to \$350. Some districts charge renewal fees up to \$75 per year. Pro hac vice fees range from no fee to \$550.

Admission Fees for New Membership

Admission fees for membership in federal district-court bars range from the national minimum of \$199 (twenty-two districts, or 23%) to \$350 (the District of Guam). Nearly two-fifths of the districts add from \$1 to \$35 to the national fee (thirty-seven districts, or 39%). A little over one-fifth charge about \$250 total (twenty-one districts, or 22%). Six districts charge from \$261 to \$275 (6%), and four charge about \$300 (4%). The four districts with the highest fees charge from \$318 to \$350 (4%).



Renewal Fees

Twenty-five districts (27%) charge dues, often referred to as renewal fees. Renewal periods range from one to six years, and annualized dues range from \$3 to $75.^{6}$

Appearance Pro Hac Vice

Thirty districts (32%) charge the most common pro hac vice fee of \$100. Sixteen districts (17%) charge less than that, including two districts with no fee (the Western District of Michigan and the Eastern District of North Carolina). Five districts charge more than \$300.⁷ Three districts charge pro hac vice renewal fees.⁸ Four districts do not permit pro hac vice appearance; their bars are open to members of any state bar.⁹



Federal District-Court Pro Hac Vice Fees

Local-Counsel Requirements

Fifty districts (53%) at least sometimes require participation by local counsel for admission to the district court's bar, such as by acting as a sponsor.¹⁰

Fourteen districts (15%) at least sometimes require litigation participation by local counsel for some members of the district court's bar.¹¹

In addition, the Western District of Michigan allows, but disfavors pro hac vice appearance.

A large majority of districts (seventy-two, or 77%) require members of the district court's bar to participate in applications for pro hac vice appearance, or to associate with the appearance itself, at least sometimes.¹² Eighteen districts (19%) do not require participation by local counsel in pro hac vice appearances.¹³ Four districts (4%) do not permit pro hac vice appearances.¹⁴

Government Attorneys

It is common for local rules to specify waiver of fees and mitigated admission requirements for government attorneys. Sometimes this includes state or local government attorneys as well as federal government attorneys. Sometimes this includes federal defender attorneys and sometimes also other attorneys compensated under the Criminal Justice Act. A few courts also specify mitigated requirements for public-interest attorneys. Textual specifications that appear similar may be interpreted differently, and textual specifications that appear different may be interpreted similarly.

APPENDIX COMPILATION OF RULES AND FEES

The following compilation of federal bar-admission rules simplifies and summarizes many rules for ease of comparison. References to federal court bars include summaries of rules more specifically referring to federal district-court bars. References to territory bars include bars for the District of Columbia, Puerto Rico, Guam, the Northern Mariana Islands, the Virgin Islands, and American Samoa. Many, but not all, courts that specify membership in a bar in any state as a requirement for admission to the court's bar implicitly include membership in the District of Columbia's bar.

This compilation excludes provisions for student practice and excludes any special rules for bankruptcy courts. A 2015 compilation of rules for membership in the district courts' bars prepared by the District of Maryland focused on reciprocity rather than fees, and examples of possible reciprocity rule changes since then are noted.¹⁵

The rules compiled here do not apply to an attorney in a case transferred by the Judicial Panel on Multidistrict Litigation, who "may continue to represent his or her client in any district court of the United States to which such action is transferred. Parties are not required to obtain local counsel."¹⁶

District of Columbia Circuit

"[O]n motion for good cause shown, the court may allow argument to be presented in a case by an attorney who is not a member of the bar of this court." D.C. Cir. R. 46(a).

First Circuit

The admission fee is \$249: the national fee plus \$50. 1st Cir. R. 46.0(a)(1). No fee is required for the following (Notice for Application for Admission, www. ca1.uscourts.gov/sites/ca1/files/admission.pdf):

- an attorney representing the federal government
- an attorney appointed under the Criminal Justice Act

"At this time, members of the First Circuit bar are not required to apply for readmission or pay a renewal fee." Attorney Admissions, www.cal.uscourts. gov/attorney-admissions.

Second Circuit

The term of admission is five years. 2d Cir. R. 46.1(a)(2). The renewal fee is \$25. Fee Schedule, *supra*.

Pro hac vice admission for a particular proceeding without payment of the admission fee is by motion in the following circumstances (2d Cir. R. 46.1(d)):

- an attorney for a criminal defendant who is a member of a districtcourt bar within the circuit
- an attorney representing a party in forma pauperis
- an attorney acting in exceptional circumstances justifying pro hac vice admission

Third Circuit

The admission fee is \$239. Third Circuit Court of Appeals Miscellaneous Fee Schedule, www.ca3.uscourts.gov/sites/ca3/files/FeeSchedule.pdf.

Fourth Circuit

The admission fee is \$239: the national fee plus \$40. 4th Cir. R. 46(b). No fee is required for the following (*id.*):

- attorneys appointed by the court to represent a party in forma pauperis
- federal government attorneys
- law clerks for judges in the circuit

"An attorney may be named on a brief filed in this Court without being admitted to the bar of the Fourth Circuit, provided that at least one lawyer admitted to practice in this Court also appears on the brief." 4th Cir. R. 46(b).

Fifth Circuit

- an attorney representing an appellant in forma pauperis
- an attorney representing the federal government
- an attorney newly graduated and licensed to practice in a Fifth Circuit state
- an attorney on orders for extended active duty in the Judge Advocate General's Corps

A certificate of good standing is required, except for federal government and judiciary attorneys and attorneys admitted to the other bar within thirty days, in which latter case, admission documentation is required. The term of admission is five years. 5th Cir. R. 46.1. Only the \$50 local fee is required for renewed admission. Unites States Court of Appeals Fee Information, *supra*.

Sixth Circuit

The admission fee is \$249: the national fee plus \$50. Admission to the Bar of the United States Court of Appeals for the Sixth Circuit, www.ca6.uscourts.gov/ sites/ca6/files/documents/attorneys/AttyAppInstructions.pdf. No fee is required for the following (6th Cir. R. 46(a)(2)):

- an attorney appointed by the court representing a party in forma pauperis
- attorneys working for a federal defender
- attorneys employed by a U.S. court
- Formal admission is not required for the following (6th Cir. R. 46(a)(1)):
- federal government attorneys
- federal defender attorneys
- attorneys for amici curiae

Seventh Circuit

According to the court's 2020 "Practitioner's Handbook for Appeals" (www. ca7.uscourts.gov/rules-procedures/Handbook.pdf, p.14), the admission fee is the national fee plus \$15, which is stated to be \$196. If the \$15 figure remains correct, the admission fee would be \$214. No fee is required for the following (7th Cir. R. 46(b)):

- an attorney representing the federal government
- an attorney appointed under the Criminal Justice Act

"Attorneys for any federal, state or local government office or agency may appear before this court in connection with their official duties without being formally admitted to practice before the court." 7th Cir. R. 46(c).

Eighth Circuit

The admission fee is \$221. 8th Cir. R. 46A.

Formal admission is not required for an attorney appointed to represent a party proceeding in forma pauperis. 8th Cir. R. 46A.

Ninth Circuit

The admission fee is \$230. Fee Schedule, www.ca9.uscourts.gov/general/fee-schedule/.

Tenth Circuit

The admission fee is \$225. Filing Fees, www.ca10.uscourts.gov/reference/filing-fees. No fee is required for the following (10th Cir. R. 46.2(B)):

- an attorney representing the federal government
- an attorney appointed to represent a party on appeal

The term of admission is five years. 11th Cir. R. 46-2. The renewal fee is \$20. Fee Schedules, *supra*.

The pro hac vice fee is \$50. Fee Schedules, supra.

Federal Circuit

The admission fee is \$300: the national fee plus\$101. Fee Schedule, cafc. uscourts.gov/wp-content/uploads/FeeSchedule.pdf.

Formal admission is not required for an attorney representing a federal, state, or local government office or agency. Fed. Cir. R. 46(d).

Admission may be by the attorney's own motion. Fed. Cir. R. 46(b)(3).

Alabama State Bar

There is no charge for a certificate of good standing. Members, www.alabar. org/members/.

Middle District of Alabama

Bar Admission

Admission to the state bar is required. M.D. Ala. R. 83.1(a)(1). The attorney must either present a certificate of good standing from the district court where the attorney lives or works, *id*. (1)(B), or have admission moved by the court or a current member of the district court's bar, *id*. (A). A federal government or defender attorney may appear without formal admission. *Id*. (c)–(d).

An attorney who is a member of the district court's bar where the attorney lives or works may be granted admission pro hac vice. *Id.* (b)(1).

Northern District of Alabama

Bar Admission

Attorneys who are members of the state bar and who live or work in Alabama are eligible. N.D. Ala. R. 83.1(a)(1). Admission is by motion of a current member of the district court's bar or by the court. *Id.* (1)(A).

Federal government and defender attorneys may appear specially without formal or general admission. *Id.* (c).

An attorney admitted to a federal or state bar where the attorney lives or works may be permitted to appear pro hac vice. *Id.* (b)(1). The attorney must designate local counsel, and "[e]xcept as otherwise ordered by a judge of the court in a particular case, the designated local counsel must at least review and sign all pleadings and other papers filed in the case by the attorney appearing pro hac vice." *Id.* (2).

Bar Admission

Admission to the state bar is required. S.D. Ala. Gen. R. 83.3(b). In addition, the attorney must be a member of the district-court bar where the attorney lives or works. *Id.* (b)(2). Admission is by motion by a current member of the district court's bar or by the court. *Id.* (1). Membership must be renewed every five years. *Id.* (c). Federal government and defender attorneys may appear without formal admission to the court's bar. *Id.* (f)–(g).

The court may require the appearance of local counsel if an attorney appearing does not live in the district. *Id.* (e).

An attorney who is a member of a state or District of Columbia bar or a member of the bar of the district court where the attorney lives or works may move for pro hac vice admission. *Id.* (d)(1).

District of Alaska

Bar Admission

Admission to the state bar is required. D. Alaska Civ. R. 83.1(a).

A member of another jurisdiction's bar may be permitted to appear pro hac vice and may be required to associate a member of the district court's bar. *Id.* (d)(1). Federal government and defender attorneys and attorneys representing persons appearing in forma pauperis may appear without pro hac vice fee if admitted to the bar of a state. *Id.* (e).

District of Arizona

Bar Admission

Admission to the state bar is required, Ariz. Civ. R. 83.1(a), except for federal government and defender attorneys, for whom admission to another district-court bar is required, *id*. (b)(1). Admission is by motion by a current member of the district court's bar. *Id*. (a).

An attorney admitted to practice before another district court may be admitted pro hac vice unless the attorney lives or works in Arizona. *Id.* (b)(2).

Attorneys representing tribal governments may also apply to appear pro hac vice. *Id.* (3).

"Nothing herein shall prevent any judicial officer from ordering that local counsel be associated in any case." *Id.* (d).

Members of the bar for the Western District of Arkansas are also members of the bar for the Eastern District. E.D. & W.D. Ark. R. 83.5(a), (b)(3). Other attorneys are eligible for membership if licensed where they principally work and either residents of Arkansas or previously admitted to another district court's bar. *Id.* (b)(2).

Unless the court waives this requirement, a pro hac vice application "shall designate a member of the Bar of these Courts who maintains an office in Arkansas for the practice of law with whom the court and opposing counsel may readily communicate regarding the conduct of the case." *Id.* (d). "The Rule

shall not apply to any attorney for the United States appearing in his official capacity." *Id.*

Western District of Arkansas

Bar Admission

Members of the bar for the Eastern District of Arkansas are also members of the bar for the Western District. E.D. & W.D. Ark. R. 83.5(a), (b)(3). Other attorneys are eligible for membership if licensed where they principally work and either residents of Arkansas or previously admitted to another district court's bar. *Id.* (b)(2).

A member of a federal, state, or territory bar may be permitted to appear pro hac vice. *Id.* (d). Unless the court waives this requirement, a pro hac vice application "shall designate a member of the Bar of these Courts who maintains an office in Arkansas for the practice of law with whom the court and opposing counsel may readily communicate regarding the conduct of the case." *Id.* "The Rule shall not apply to any attorney for the United States appearing in his official capacity." *Id.*

Bar Admission

Admission to the state bar is required. C.D. Cal. R. 83-2.1.2.1. The court charges an annual renewal fee. *Id.* 83-2.1.2.3. The admission fee is waived for federal government attorneys who are members of the California bar. *Id.* 83-2.1.4.

A member of a federal, state, or territory bar who does not live or work in California may apply for pro hac vice appearance. *Id.* 83-2.1.3.1 to .2. The applicant must associate a member of the district court's bar who works in the district. *Id.* 83-2.1.3.4.

Eastern District of Washington

Bar Admission

Admission to the state bar is required. E.D. Wash. Civ. R. 83.2(a)(1). Certificates from two current members of the district court's bar must accompany the petition for admission. *Id.* (b)(1)(B). An attorney working for the U.S. attorney or the federal defender who is a member of a state bar is eligible for conditional membership in the district court's bar. *Id.* (a)(2). Instead of two certificates from current members, the attorney must provide a verification

from an attorney in the attorney's federal office. *Id.* (b)(2)(B). A federal government attorney employed outside of the district may appear if the attorney is a member of a state bar. *Id.* (3).

A member of a federal, state, or territory bar who neither lives nor works in Washington may be permitted to appear pro hac vice in association with a member of the district court's bar, who must sign all filings and participate meaningfully in the case. *Id.* (c)(1).

Western District of Washington

Bar Admission

Admission to the state bar is required. W.D. Wash. Civ. R. 83.1(b), Crim. R. 62.1(b). A government attorney may be conditionally admitted if the attorney is a member of another state's bar. *Id.* Civ. R. 83.1(b), (c)(2); *id.* Crim. R. 62.1(b), (c)(2). A petition for admission must include certificates from two reputable members of the district court's bar who live or work in the district. *Id.* Civ. R. 83.1(c)(1), Crim. R. 62.1(c)(1).

An attorney who neither lives nor works in the district and who is a member of a federal, state, or territory bar may be permitted to appear pro hac vice in association with local counsel, who must sign all filings absent the court's waiver of this requirement. *Id.* Civ. R. 83.1(d), Crim. R. 62.1(d). "Attorneys who are admitted to the bar of this court but reside outside the district need not associate with local counsel." *Id.* Civ. R. 83.1(d)(1), Crim. R. 62.1(d)(1).

Northern District of West Virginia

Bar Admission

Admission to the state bar is required. N.D. W. Va. Gen. R. 83.01(a). A motion by a current member of the district court's bar is required. *Id.*

Visiting attorneys licensed in another state or country or in the District of Columbia may appear pro hac vice in association with a member of the district court's bar and West Virginia's bar who primarily practices in West Virginia. *Id.* Gen. R. 83.02(a). In addition to the fee required by the district court, a pro hac vice fee is required by the state bar. *Id.* (a)(3). Local counsel must sign all

pleadings and filings and attend all hearings, trials, proceedings, and depositions. *Id.* (b). "With prior permission of the Court, local counsel will not be required to attend routine court hearings or proceedings." *Id.*

"This section does not apply to properly licensed attorneys with the United States Department of Justice, those associated with federal executive branch agencies, and those appointed from outside the district pursuant to the Criminal Justice Act, 18 U.S.C. § 3005A and § 3006A." *Id.* (c)(4).

Admission to the state bar is required. S.D. W. Va. Civ. R. 83.1(a), Crim. R. 44.1(a). A motion by a current member of the district court's bar is required. *Id*.

An attorney is entitled to appear pro hac vice if admitted to a United States Supreme Court, state, or District of Columbia bar and associated with a member of the district court's bar who primarily practices in West Virginia, and who must sign all papers requiring an attorney's signature. *Id.* Civ. R. 83.6(a), Crim. R. 44.6(a). The fee is waived for federal government attorneys, *id.* Civ. R. 83.6(d)(4), Crim. R. 44.6(d)(2), and for other attorneys on a showing of good cause, *id.* Civ. R. 83.6(e), Crim. R. 44.6(e).

Admission requires an affidavit or an oral attestation from a current member of the district court's bar. *Id.* (2)(A)(i). Federal government attorneys are deemed admitted. *Id.* (D). "At any time, upon its own motion, the Court may require that a nonresident attorney obtain local counsel to assist in the conduct of the action." *Id.* (A)(3).

Pro hac vice admission is not permitted. Id. (E).

"Non-resident lawyers need not retain local counsel to assist in the presentation of their cases unless specifically directed to do so by a judge or magistrate judge." *Id.* 83.5.D.

"Any lawyer eligible for membership in the bar of this court may, upon payment of the prescribed fee, move the court to proceed in a particular matter without becoming a member of the bar of this court." *Id.* 83.5.B.

Admission to the state bar is required. D. Wyo. R. 84.2(a).

Local counsel may move for admission pro hac vice of an attorney not admitted to the state bar. *Id.* (b). "Unless otherwise ordered by this Court, a motion to appear pro hac vice shall be granted only if the applicant associates with local counsel who shall participate in the preparation and trial of the case to the extent required by the Court." *Id.* Federal government attorneys may appear if admitted to another state's bar upon motion by an attorney in the U.S. Attorney's Office, who must sign pleadings and appear in court, unless excused by the court. *Id.* (d).

Any attorney who is currently a member of good standing and admitted to practice in the highest court of any state or the District of Columbia, who is not otherwise qualified to practice in this Court, may appear, upon consent of the Court, in any criminal matter initiated within the boundary of Yellowstone National Park. Such attorneys need not be admitted pro hac vice or associate with local counsel.
